- Tear-down and load-out time is 7.00p.m. **NO EXCEPTIONS.**
- Vendors will be provided with the location of their booth on the Friday immediately preceding the event (subject to modification).
- All vendors must sign-in at the LLL Acquisitions booth and confirm booth location.
- All vendors must staff their site during operating hours. LLL organizers do not accept the responsibility for any vendor's possessions left on-site for the duration of the event or after the event.
- All vendors' company display signs must be visible at all times.
- All vendors will be restricted to display/sell within their assigned areas. Failure to do so will result in closing of booth and removal from the grounds.
